# HISTORY

On October 8, 1974, the California Association of Postsecondary Educators of the Disabled was formally founded by the adoption of bylaws. The major purpose of the organization was to promote professional development, and to advance postsecondary educational opportunities for students with disabilities. CAPED later modified our name to the California Association for Postsecondary Education and Disability. Our mission and purpose would remain unchanged.

The founding of CAPED followed three years of federally funded (Education Professions Development Act) workshops designed to train California Community College personnel on how to work effectively with students with disabilities. In April of 1975, with a membership of 86, CAPED was formally incorporated by the State of California as the first non-profit, professional organization of postsecondary educators of students with disabilities in the nation.

During the early years, the Association attempted to respond to a multitude of diverse interests and needs across all of California's segments of postsecondary education through the establishment of CAPED Interest Groups (CIGS) and a burgeoning number of special committees and task forces – the most recent of which deals with the returning veteran who, perhaps unknowingly, is newly disabled. CAPED has further evolved in recent years through the addition of staff for fund-development and asset management. We also have tools such as monthly – or immediate if the cause merits digital updates regarding the organization's activities and information of general interest to those involved with students with disabilities at postsecondary institutions across the state. CAPED is viewed as the pre-eminent organization for faculty, staff, managers and students in all of California's institutions of postsecondary education.

To facilitate collaboration and professional development that promotes and models equal access and educational opportunities for students with disabilities in California higher education.

- To facilitate the exchange of current information, issues and techniques among personnel and agencies serving persons with disabilities

- To inform the public about higher education programs and services for persons with disabilities.
- To promote high standards and success in higher education programs and services for persons with disabilities.
- To promote, conduct, and report on research related to higher education and persons with disabilities.
- To advance high standards of professional ethics and integrity among those who instruct, or provide programs and services for persons with disabilities.
- To conduct educational and/or professional meetings on disability issues and concerns affecting education and transition.
- To remain technologically current and promote the use of accessible technology in every aspect of the organization.

• To respond to the legislative needs of individuals with disabilities in accordance with rules governing CAPED's non-profit status as stated in its Articles of incorporation.

### CAPED'S MENTORSHIP PROGRAM - YEAR TWO HIGHLIGHTS Lucinda Aborn, Ph.D, CRC; Program Coordinator <u>lucindaaborn@outlook.com</u>

CAPED launched the third year of the Mentorship Program in September 2018. The program is designed to provide support to new Directors/Coordinators in the California Community Colleges. CAPED's Mentorship Program (CMP) brings the expertise of CAPED Leaders, DSPS Solutions/Interwork Institute and the Chancellor's Office to provide the mentorship pairs with best practices, training and individualized support. The CMP completed its third year with many successes and measurable outcomes. The California Community Colleges Chancellor's Office provided funding for the 2018-2019 third year program continuation. Dr. Lucinda Aborn continued as the Coordinator for the CMP overseeing project activities throughout the year.

Activity on the project began in July and August with building the Canvas Course structure and training topics that would support interaction and learning. In September the CMP Coordinator attended the Chancellor's Office New Director's Training. Protégé profiles were gathered and Mentors were matched according to region, expressed areas of need for expertise, campus size and other factors. Over 25 new Directors indicated an interest in the program. Mentors were recruited from a pool established from last year's program as well as other seasoned leaders who expressed interest in participating. The CMP began with 18 Protégé/Mentor pairs who represented all 10 regions of the state. Twenty-two of the pairs completed activities to the end of the project year.

Overall the CAPED Mentorship Program was successful in meeting the outcomes stated in the original proposal. The work plan was carried out with modifications. The evaluation evidence indicates the learning outcomes were achieved and met the expectations of the services and knowledge foundation for new DSPS Directors. There were unintentional positive outcomes which benefited the Mentors in their careers as they learned best practices. CAPED plans to continue organizational support for the CMP activities into a fourth year. The Chancellor's Office has approved funding for the 2019-2010 year.

This year the AT CIG and its members, as a result of last year's audit of the Alternate Media Services, and the Addendum to Guidelines for Producing Instructional and Other Printed Materials in Alternate Media (July 2018) revised their processes and procedures to ensure their services were following the timelines outlined in the Addendum. Many were pleased to see the additional guidelines. Most campuses already had guidelines in place that followed the additional more specific criteria, the others used this information to put in writing specific procedures that can now be documented and reported if required.

The AT CIG is hosting a fantastic Pre-Con workshop at CAPED this year. In the morning, Mike Sauter will be presenting Sonocent Audio Notetaker Exploration: More than a training, we will explore the software from A-Z. # LEARNING DISABILITIES CIG

### Alicia Hallex/ Jenna French

The LD CIG offered two \$1000 student scholarships in 2018. The Susan Bunch Memorial Scholarship and Dick Griffith Memorial Scholarship is awarded to a student with a learning disability who is pursuing higher education.

At the 2018 CAPED Convention, Jenna French, LD Specialist at Cañada College was unanimously elected as the new LD CIG Northern co-chair for Northern California. Dr. Inga Maples two year term as the LD CIG Northern co-chair ended at the convention.

Alicia Hallex held an LD Business meeting on Friday, April 26, 2019, at the CAPED Spring Drive-in hosted by Long Beach City College for the Southern Region. Six participants attended. The CAPED Northern CA LD CIG meeting was held on April 25th 2019 from 9am to 11am at Contra Costa College. There were 15 attendees at the meeting. After the meeting, the LD CIG hosted the two day workshop on Bilingual Assessment of Learning Disabilities presented by Patricia Flores-Charter, MA, Bilingual LD Specialist. This workshop was designed for anyone working with English Language Learners who are bilingual or monolingual English speaking. There were 10 attendees on the first day of the workshop and 6 attendees on the second day.

The LD CIG offered the LD Professional Development Stipend this year. The LD CIG sent out notice to members about how to apply. Unfortunately, we had no qualified applicants.

The LD CIG invited Patricia Charter-Flores, Learning Disabilities Specialist, to host a full day Pre-Con on October 11th, 2019. The workshop will examine case studies to further develop interpretation skills in using the Intake, behavioral observations, and test results to improve student efficiency and effectiveness in learning. The outcome will be to have handouts and experiences that guide quick interpretation of test results for the LD Specialist and the student. Tips on using comprehensible language with the student will be provided.

# ASD-ID CIG Adam Gottdank/Alina Sala

The ASD-ID CIG has focused primarily on the Spring Drive-In and the 2019 Conference Planning. The CIG sponsored a Spring Drive-In presentation by Brandon Owens from North Orange Continuing Education on Mental Health. Brandon presented the research he did on behalf of the North Orange County Regional Consortium for Adult Education (NOCRC) related to identifying the needs of students with mental health disabilities in the region, and making recommendations for new services to better meet their needs. The CIG co-sponsored with the UCLA Tarjan Center a webinar on Universal Design for Learning (UDL) held on May 13<sup>th</sup>. The webinar was intended to be a pre-cursor to the UDL presentation that will be featured at the Fall CAPED conference. Jordan Knab from the University of South Florida, St. Petersburg, presented during the webinar and we have arranged for him to provide a full-day Pre-Con seminar at this Fall's CAPED conference. Jordan and Brandon will also present as a panel on Mental Health for the upcoming conference. Members of the CIG helped to identify two keynote speakers for the fall conference. Diana De La Garza is a former Dallas Cowboys cheerleader and parent of three children including Demi Lovato (singer, songwriter, and actress). Diana's keynote will focus on Mental Health. She is also going to provide a break-out session on being a parent of a first year college student who has a mental health disability. The second keynote speaker is Roni Habib who will present, "Teaching to the Human Core."

The ASD-ID CIG is looking to re-define, in order to identity relative issues membership may be dealing with on their respective campuses.

## COUNSELING AND CAREER DEVELOPMENT CIG

The Counseling and Career Development CIG has been busy this year with a number of different activities. The CIG has been continuing to engage members by providing information about relevant webinars, conferences, career opportunities, AB 705 implementation, and the CAPED call for proposals. Rachel Stewart (Northern California CIG chair) also facilitated a meeting between CIG member, Alina Sala, and the Director of Special Education, Kristin Wright, to discuss AB 705 implementation and the impact on transition outcomes for students leaving the K-12 system. Additionally, CIG member, Brandi Bass, submitted an article titled "Have You Heard About Work-Based Learning?" for the fall edition of the Communique. The article aims to familiarize DSPS counselors with the concept, as well as the ties with Guided Pathways and Vision for Success.

The CCD CIG chairs helped to plan another pre-convention workshop at this year's CAPED convention entitled, "Individualized Approaches Coming Together to Support Employment For Students". This session will be led by CIG Chairs and CIG members to provide information about tips and strategies for job development, connecting with employers, and building business

partnerships leading to opportunities for students. The pre-con will also address the intersection of guided pathways and career exploration/assessments, and how DSPS counselors can support students with disabilities in finding appropriate career pathways. Additionally, Rachel Stewart has been working with the DOR cooperative program section to plan an engaging and interactive annual meeting for the WorkAbility III, WorkAbility IV, and C2C programs, to be held during the Saturday pre-con.

This year the CIG also decided to offer a Counseling and Career Development scholarship for the first time. The scholarship is in support of students with disabilities wishing to make an impact in the fields of counseling, disability services, or employment services for the disability community.

# DHH CIG

We began our momentum at the 2019 CAPED Mentorship Program hosted in Long Beach, CA where Dr. Rutland presented her informative workshop entitled: "Working with Sign Language Interpreters in Post-Secondary Education: A Holistic Approach." We received feedback from an attendee stating that Dr. Rutland's workshop was "insightful, comprehensive and encouraging...glad someone in her position could reiterate how to best support DHH students to a room full of managers and directors who typically have very little understanding of what we do" (anonymous).

During the 2018 CAPED conference in Burlingame, CA members have expressed their concerns regarding the AB705 that has impacted the DHH student community. In response, the DHH CIG has taken the opportunity to identify and provide a refreshing method implemented at Mt. San Antonio College. We invited Julie Brady, MS DHH/ACCESS Counselor and her team of Professors to share their unique approach, knowledge and data in supporting the learning needs of the DHH student. This Pre-Conference workshop entitled: "Optimizing DHH Student Success through

Collaboration and Accommodation", was hosted at the CAPED 2019 "MANY RIVERS, ONE OCEAN" conference at the Renaissance Hotel in downtown Long Beach, CA.

In addition to the Pre-Conference, the DHH CIG was thrilled to have been able to provide its' members with several stimulating workshop that followed. LFMT from Orange County Health Agency, Belinda McClesse led her topic entitled: "Deaf & Hard of Hearing Students in Post-Secondary Education Settings and Mental Health", Director of Sales Signglasses Joseph Featherstone provided demonstration of the newest technology in providing a platform that is a one stop solution for students, directors, and interpreters/captionsist. To conclude our 2019 DHH CIG program, we were honored to have Lecturer and Doctoral Candidate studying at CSU-Northridge Rezent Moges-Riedel in her topic "The Plight of Deaf Faculty of Color: Their Intersectional and Retention Experiences in Predominately Hearing and White Postsecondary Institutions".
